RENTAL AGREEMENT

- 1) I ACCEPT FULL RESPONSIBILITY FOR THE CARE OF THE Rental Equipment("the Equipment")listed on this form and I agree to pay for any damage to the Equipment and replace at full retail value any Equipment not returned by the agreed date.
- 2) I have made no misrepresentation in regard to my height, weight, age, or skier type (this information is required in order to properly adjust the ski boot/binding settings). I agree to verify that the rental technicians are able to answer any questions I may have as to the proper use of the Equipment.
- 3) I am familiar with the proper use of the Equipment. I understand that the rental technicians are able to answer any questions I may have as to the proper use of the Equipment.
- 4) I also agree to return the Equipment in clean condition to avoid any additional charges.

ASSUMPTION OF RISKS

I am aware that skiing, snowboarding, snowblades, and skiboarding involves risks, dangers and hazards, and that injuries are a common and ordinary occurrence of these sports.

SKIING. I understand that the ski boot/binding system will not release at all times or under all circumstances; that it is not possible to predict every situation in which the system will release, and that the system is no guarantee that the user will not be injured.

SNOWBOARDING/SNOWBLADES/SKIBOARDING. I understand that the boot/binding system for this Equipment is not designed or intended to release under normal circumstances. I understand that as the boot/binding system is a non-release system, this system will not reduce the risk of injury during a fall and will increase the risk of not surviving an avalanche.

HELMETS. I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slower speeds. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I freely accept and fully assume all risks, dangers and hazards associated with the use of the Equipment.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the rental of the Equipment, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have, or may in the future have against, LONG LAKE SKI AREA and to the manufacturer and distributor of the Equipment, and the directors, officers, employees, agents, representatives, successors, and assigns (all of whom are hereinafter collectively referred to as "the Releasees") and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, resulting from or arising out of any aspect of my use of the Equipment, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF WARRANTY ON THE PART OF THE RELEASEES in respect of the design, manufacture, selection, installation, maintenance, or adjustment of the Equipment, or in respect of the provisions of, or the failure to provide any warnings, directions, instructions, or guidance as to the use of the Equipment.
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to any third party resulting from my use of the Equipment.
3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, and representatives, in the event of my death or incapacity;
4. This Release Agreement shall be governed by and interpreted in accordance with the laws of the Province of Alberta, and
5. Any litigation involving the parties to this agreement shall be brought within the Province of Alberta.

I have read and understand this Agreement and I am aware that by signing this Agreement I am waiving certain legal rights, which I or my heirs, next of kin, executors, administrators, and representatives may have against the releasees.
